**Package 1:** Includes 3 sets of CDs of all images taken at your event, minimum of 60 color digital photos, and all rights and privileges for reproduction of the images.

**Package 2:** Includes 3 sets of CDs of all images taken at your event, and a suitable wedding album with 100 + 4" x 6" professional color photograph prints.

**Package 3:** Work with Henry to design your own package. Pricing starts at \$250/hour, with a two (2) hour minimum.

***Each package includes digital picture files of photographs taken at the wedding, family and formal photographs and post-wedding/reception photographs.\****

**\*ADDITIONAL FEES**

- Mileage Rate: Events outside of Manistee County, round-trip mileage from the photographer's residence will be added as an additional fee. (Current Federal Mileage Rate applies.)

The balance to be paid on the day of the event. Additional photographs and albums can be purchased if so desired at the current rate.

The Photographer also warrants that upon full payment of the wedding contract, the above signed parties gain all rights and privileges for duplication of the images presented in their wedding album. Unless otherwise requested in writing, including signature and date and received prior to the event, the Photographer may use images from your event for display in their portfolio and for business promotion.
